



SHOWTIME TERMS AND CONDITIONS

GENERAL RELEASE OF LIABILITY:

Being aware that there is a risk of injury involved whenever children are involved in physical activity, I agree to release and hold Showtime USA – St. Johns, Kelly Williams, Miss Pam Productions, Inc., d/b/a Showtime U.S.A. and USA Camps & Tours, Pamela G. Masters, it's officers, agents, and employees, harmless from any damages or physical injury that is incurred while my child is involved with Showtime U.S.A. attending classes and performances. I accept the risk of and agree to hold Showtime USA – St. Johns, Kelly Williams, Miss Pam Productions, Inc., Showtime U.S.A, USA Camps and Tours, and Pamela G. Masters, its officers, agents and employees, harmless from all responsibility for damages or physical injury incurred in transporting my child to and from class and performances.

PERMISSION is hereby given for any pictures and/or videos taken of my child to be used for publicity. (including, but not limited to: newspaper, Facebook, website, twitter, youtube, or other social media, etc.)

PAYMENT OF MEMBERSHIP FEES: Payment of the annual and monthly membership fees are due at the time of billing and shall be paid by check, cash, or debit/credit card by the 5th day after the billing date. A late fee of \$15.00 will be assessed after the 5th of each month. A charge of \$35.00 will be charged for all returned checks. Students will not be allowed to attend any class(es) if tuition remains unpaid after the 5th of each month. Students must be in the class prior to a show to be staged for that show.

All membership fees will continue to be assessed and billed as set forth above until such time that I give written notice of withdrawal from membership in Showtime USA.

IT IS UNDERSTOOD that an annual membership fee, to help offset the cost for production expenses, recording studio fees, and choreography fees will be billed to my account at the time of registration and a monthly membership fee will be billed to my account on the first of each month. These membership fees do not include nor provide tickets or entrance fees to any performances/productions that require a paid entrance fee/ticket. Annual and monthly membership fees are as follows:

- **Annual Membership Fees (Billed at time of registration):**
 - Singing Stars: \$ 70.00
 - Cajun Kids, Main Street, Ambassadors: \$125.00

- **Monthly Membership Fees (Billed on the first of each month):**
 - Singing Stars: \$75.00 per month
 - Cajun Kids, Main Street, Ambassadors: \$85.00
 - La'Deez Only: \$50.00 per month
 - Company: \$50.00 per month

Summer Tour Cancellation/Refund Policy

Summer Tour is usually held in June (depending on when our cast members get out of school). Tour is usually two days and one night. Tour fees are approximately \$315.00 per seat which includes hotel room fees (based on four (4) people to a room), bus fares, admissions, and sightseeing. To help out in planning and saving, deposits for tour can be made all year long into your Showtime “special events account”; however, tour deposits are officially due in January of each year. **NOTE: Summer tour is MANDATORY for all Showtime cast members, except Singing Stars. All Main Street, Cajun Kids, and Singing Stars aged Cast Members are required to have a parent/guardian on tour with them.**

PAYMENT OF SUMMER TOUR FEES: Payment of the summer tour fees are due at the time of billing and shall be paid by check, cash, or debit/credit card by the 5th day after the billing date

Tour Payments: The initial deposit of \$75.00 per seat is due in the month of January with additional payments due monthly until the final payment, which is due in April. **** Late tour payments will result in cast member(s) not being able to attend classes and will be assessed a late fee of \$15.00 per installment payment until tour payments are made current.** Tour Payments will be billed and due as follows:

- January 15th: \$75 per seat
- February 15th: \$75.00 per seat reserved
- March 15th: \$75.00 per seat reserved
- April 15th: Balance Due per seat reserved

Tour Opt-Out Policy: As stated, summer tour is mandatory for all cast members; however, if any cast member wishes to opt-out of tour, they may do so by paying an opt-out fee of \$100.00. The opt-out fee is to be paid as follows: \$100.00 due at time of January Payment.

Cancellation/Refund Policy: Showtime USA – St. Johns reserves the right to cancel its summer tour at any time. If Showtime USA – St. Johns cancels a tour, you will receive a full refund of all payments made to date of cancellation.

A Cancellation Fee of \$100.00 per seat reserved shall be assessed if cancellation is made by the parent/guardian of any cast member after the March payment due date and before April 15th. Said cancellation fee is equal to the tour opt-out fee, which is a non-refundable deposit should the parent/guardian of any cast member cancel at any time before the April 15th.

No credit or refund is available if the parent/guardian of any cast member cancels after April 15th; if you do not show up; or if you leave tour early for any reason. No refund will be available if you attend a tour and are dissatisfied with its content.

NOTE: All cancellations must be made in writing by the parent/guardian of the cast member. Verbal cancellations or cancellations made by cast members are not allowed.
